

ORDINANCE NO. 2021-09

AN ORDINANCE TEMPORARILY AND RETROACTIVELY AMENDING THE RESPONSIBILITIES, DUTIES, AND SALARY OF THE VILLAGE FISCAL OFFICER AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO.

WHEREAS, the Village of DeGraff (the "Village") Fiscal Officer duties are currently as set forth in R.C. § 733.262 and as set forth in the attached and incorporated Exhibit A;

WHEREAS, the Village desires to temporarily modify the duties of the Village Fiscal Officer to include the duties of the Utility Clerk on a trial run basis;

WHEREAS, the Village understands that the inclusion of said additional duties will result in a greater workload and requirement for more hours, and, as such the Village desires to appropriately and fairly compensate the Village Fiscal Officer;

WHEREAS, the Village Fiscal Officer has already undertaken the additional duties since January 25, 2021;

WHEREAS, the Village seeks to make changes on a temporary, trial-run basis to ascertain the effectiveness and efficiency of the assumption of duties by the Fiscal Officer;

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, OHIO:

SECTION I: That the duties of the Fiscal Officer are hereby amended, retroactive to January 25, 2021, to include the duties of the Utility Clerk, said duties being identified in the attached and incorporated Exhibit B and otherwise on file at the Village Utility Office;

SECTION II: That said duties shall remain in place until otherwise modified or made permanent by the Village Council by way of Ordinance;

SECTION III: In addition to the Fiscal Officer's salary, which shall remain unchanged with the same benefits and the Village paying all costs involved to maintain the Fiscal Officer's enrollment in the Public Employees Retirement System (OPERS) and Bureau of Workers Compensation (BWC), the Fiscal Officer shall be compensated an additional \$10,400.00 per year, in equal bi-weekly installments, retroactive to January 25, 2021, and shall be paid from the general, water and sewer operating funds.


SECTION IV: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of DeGraff, Ohio, provide for its continuous uninterrupted services, and to allow for the modification of the duties and salary of

the Village Fiscal Officer at the earliest possible time: and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.


