ORDINANCE NO. 2022-2

AN ORDINANCE MAKING SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES FOR THE VILLAGE OF DEGRAFF, OHIO DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021, AND DECLARING AN EMERGENCY (2021 SUPPLEMENTAL APPROPRIATIONS ORDINANCE)

WHEREAS, this Council, by Ordinance 2021-08, passed February 2, 2021, adopted a permanent budget and appropriations for the fiscal year ending December 31,2021 in accordance with the Ohio Revised Code Section 5705.38:

WHEREAS, it became necessary during the current year to exceed the amount which Council appropriated in various funds; and

WHEREAS, ORC 5705.38 requires this Council to adopt a Supplemental 2021 Appropriations Ordinance in order to spend additional funds received;

WHEREAS, time is of the essence in order to ensure the continued, usual, daily operation of the Village Government; and

WHEREAS, it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Revised Code Section 121.22;

NOW, THREFORE, BE IT ORDAINED by the Council of the Village of DeGraff, State of Ohio, two thirds or more of its members elected therefor concurring as follows:

<u>Section One</u>: That to provide for the current expenses and other expenditures of the Village of DeGraff, Ohio, during the fiscal year ending December 31, 2021, the following sums be and are hereby set aside and appropriated as follows:

<u>Section Two</u>: That, pursuant to ORC 5705.42, the amount of any grant or loan received from the United States government or from the State of Ohio, or any department, division, agency, authority or unit thereof, shall be deemed appropriated by this Council for the purposes set forth in the program, activity, or function of such grant or loan.

<u>Section Three</u>: That this Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public health, safety and welfare of the Village of DeGraff, Ohio, and this Ordinance shall take effect from and after the earliest period allowed by law.
