Ordinance 2022-12

AN ORDINANCE MAKING A PERMANENT APPROPRIATION OF MONIES FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES (THE OPERATING BUDGET) OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO FOR THE FISCAL YEAR ENDING DECEMBER 31, 2022 AND DECLARING AN EMERGENCY

WHEREAS, pursuant to the Ohio Revised Code, it is necessary to provide for the appropriation of funds for the year 2022.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO:

Section 1 – That to provide for the current expenses and other expenditures of the Village of DeGraff, Logan County, Ohio, for the period beginning January 1, 2022 and ending December 31, 2022, the following be and are hereby set aside and appropriated from the Village's funds, per the attached "Exhibit A," made part of this Ordinance by reference.

Section 2 – That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3 – That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the citizens of the Village of DeGraff, the immediate emergency being the necessity to provide for the current expenses and other expenditures (the operating budget) of the Village of DeGraff for the period ending December 31, 2022; therefore, this Ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
