

ORDINANCE 2022-24

AN ORDINANCE AUTHORIZING THE HIRING OF A PART-TIME INTERIM POLICE CHIEF FOR THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO, REPEALING ANY ORDINANCE IN CONFLICT THEREIN, AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO

WHEREAS, the full-time Police Chief resigned effective May 6, 2022;

WHEREAS, the Village of DeGraff is in the process of searching for a replacement Chief of Police;

WHEREAS, the Village of DeGraff believes it is necessary to employ the former police chief on a part-time interim basis for purposes of maintaining certain certifications, licenses, authorities, and other important institutional knowledge necessary to protect the health, safety and welfare of the Village of DeGraff;

WHEREAS, the former police chief has agreed to assist the Village of DeGraff in the transition of the position of Police Chief to a yet-to-be-determined police chief.

NOW THEREFORE, BE IT ORDAINED, by the Village of DeGraff, Logan County, Ohio:

Section 1: Hiring and Compensation: The Mayor is permitted to hire a part-time interim chief of police, with no fringe benefits, which shall be paid from the General Fund at the rate of \$20.00 per hour.

Section 2: Duties: The part-time interim shall serve at the pleasure of the Mayor and assist, as necessary, with the interviewing, hiring, training, and transition of certifications, licenses, authorities, and other important institutional knowledge associated with the Village of DeGraff Police Department to the new chief of police. The part-time interim police chief shall not be required to provide any patrol or enforcement unless (i) requested; and (ii) approved by the Mayor in advance. Any time worked by the part-time interim police chief shall be recorded for purposes of securing appropriate compensation.

Section 3: Duration: The duration of the part-time interim police chief shall be for a period of not more than ninety days unless specifically approved by the council of the Village of DeGraff, Ohio.

Section 5: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of DeGraff, Ohio and to facilitate

payment of compensation to said employees of the Village at the earliest time; and it shall be in force and take effect immediately upon its passage and signature by the Mayor.
