

## ORDINANCE 2022-33

### AN ORDINANCE AMENDING ORDINANCE 2022-10 ESTABLISHING THE AMOUNT OF COMPENSATION TO BE PAID TO OFFICERS OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO, AND DECLARING AN EMERGENCY

**WHEREAS**, the Mayor and the Village council of the Village of DeGraff, Logan County, Ohio are required by various statutes now in effect to establish compensation for various departments of the Village; and,

**WHEREAS**, the Mayor and the Village Council have fulfilled their statutory obligation with regard to establishing such compensation for said appointed officers.

**NOW THEREFORE, BE IT ORDAINED**, by the Village of DeGraff, Logan County, Ohio:

#### **Section 1: Officers of the Police Department**

From and after the 26 day of August, 2022 said officers of the Police Department of the Village of DeGraff, Logan County, Ohio, shall be paid bi-weekly according to the following schedule of compensation listed in Sections 2 and 3.

#### **Section 2: Schedule of Compensation for Police Department**

Position	Compensation	Hours/Month	Total Yr. Hours	Total Yr. Cost
<b>Police Chief</b>	Part-time salary	125/Mo. (29/Wk.)	1,508	\$30,357
<b>Officer(s)</b>	Part-time hourly (\$15.00/hour)	60/Mo.	720	\$10,800
		<b>Totals</b>	2,228	\$41,157

This schedule does not include other compensation.

#### **Section 3: Other Compensation**

The Police Chief will ensure that the village has at a minimum of 2,228 hours a year of Police department coverage with a payroll budget not to exceed \$41,157 a year without council and/or the mayor's approval.

**Section 4:** That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of DeGraff, provide for its continuous uninterrupted services, and to allow for said compensation of employees: and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.
