

ORDINANCE 22-7

**AN ORDINANCE ESTABLISHING THE AMOUNT OF COMPENSATION TO BE PAID
TO OFFICERS OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO,
REPEALING ANY ORDINANCE IN CONFLICT THEREIN, AND DECLARING AN
EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO**

WHEREAS, the Mayor and the Village council of the Village of DeGraff, Logan County, Ohio are required by various statues now in effect to establish compensation for various departments of the Village; and,

WHEREAS, the Mayor and the Village Council have fulfilled their statutory obligation with regard to establishing such compensation for said appointed officers.

NOW THEREFORE, BE IT ORDAINED, by the Village of DeGraff, Logan County, Ohio:

Section 1: Officers of the Fire Department: From and after the ____ day of _____, 202__ said Chief and Assistant Chief of the Fire Department of the Village of DeGraff, Logan County, Ohio, shall be paid according to the following schedule of compensation listed in Sections 2 and 3.

Section 2: Schedule of Compensation for Fire Department

<u>Position</u>	<u>Compensation</u>	<u>Total Yr. Cost</u>
Fire Chief	\$3,090.00/yr.	\$3,090.00
Assistant Fire Chief	\$800.00/yr.	\$800.00
Totals		\$3,890.00

The Fire Chief shall be paid monthly at the rate of \$257.50, for a yearly total of \$3,090.00. The Assistant Fire Chief shall be paid quarterly, for a yearly total of \$800.00. This schedule does not include other compensation.

Section 3: Other Compensation: In addition to the compensation set forth in Section 2, the Fire Chief and Assistant Fire Chief shall be paid \$7.00 per hour for each run. Hourly compensation for runs shall be paid quarterly. Further, that all the above-named employees who are non-elected, full-time employees shall be entitled to the fringe benefits equal to those of other full-time employees of the Village of DeGraff, Ohio, and benefits provided by the Village of

DeGraff, Ohio Employee Handbook, and as amended, including, but not limited to, medical benefits, that has been adopted by the Village of DeGraff, Ohio.


Section 4: That all Ordinances, Resolutions or portions thereof, which are inconsistent with the provisions hereof are hereby repealed.

Section 5: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of DeGraff, Ohio and to facilitate payment of compensation to said employees of the Village at the earliest time; and it shall be in force and take effect immediately upon its passage and signature by the Mayor.
