

ORDINANCE NO. 2025-30

AN ORDINANCE REALLOCATING FUNDS FROM APPROPRIATIONS ORDINANCE
AND AMENDING THE APPROPRIATIONS ORDINANCE
FOR PURPOSES PAYING OPERATING EXPENSES FROM APPROPRIATED FUNDS
AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO.

WHEREAS, monies within the various funds of the Village of DeGraff may be transferred within the funds according to law; and

WHEREAS, said reallocations are immediately necessary that the clerk be able to pay operating expenses and other expenses of the Village for the preservation of public peace, health, welfare, and safety of the Village of DeGraff;

BE IT ORDAINED, by the Council of the Village of DeGraff, Ohio:

SECTION I: That Ordinance No. 2025-12 passed February 12th, 2025, providing for appropriations for said Village for the year 2025, be and the same hereby is, amended to allow reallocation of funds to/from various fund line items as set forth as follows, retroactive back to February 12th, 2025, the date Ordinance No. 2025-12 was adopted:
