

**ORDINANCE NO.: 2023-43**

**AN ORDINANCE MODIFYING THE AMOUNT OF COMPENSATION TO BE PAID  
TO OFFICERS OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO**

**WHEREAS**, the Mayor and the Village council of the Village of DeGraff, Logan County, Ohio are required by various statues now in effect to establish compensation for various departments of the Village; and,

**WHEREAS**, the Mayor and the Village Council have fulfilled their statutory obligation with regard to establishing such compensation for said appointed officers.

**NOW THEREFORE, BE IT ORDAINED**, by the Village of DeGraff, Logan County, Ohio:

**Section 1: Officers of the Police Department:**

From and after the 30 day of December, 2023 said officers of the Police Department of the Village of DeGraff, Logan County, Ohio, shall be paid bi-weekly according to the following schedule of compensation listed in Sections 2 and 3.

**Section 2: Schedule of Compensation for Police Department:**

Position	Compensation	Hours/Month	Total Yr. Hours	Total Yr. Cost
<b>Police Chief</b>	Full-time salary	173.33/Mo.	2,080	\$52,000
<b>Officers 1</b>	Part-time hourly (\$15.00/hour)	60/Mo.	720	\$10,800

The full-time hours set forth for the Police Chief in the above schedule is aspirational, as the Chief will be compensated for full-time work under a typical full-time work schedule (i.e., 40 hours per week). Although the Police Chief is a salaried position, the Police Chief shall still log all hours for purposes of determining appropriate sick and vacation leave. The Police Chief will ensure that the village has at a minimum of 2,080 hours a year of Police department coverage with a payroll budget not to exceed \$62,800 a year without council and/or the mayor's approval. This schedule does not include other compensation.

**Section 3: Other Compensation:**

The Village of DeGraff, Ohio will offer the full-time Police Chief sick leave pursuant to R.C. § 124.38 and vacation leave pursuant to R.C. § 124.13. The Chief shall have all holidays identified in R.C. § 325.19. The Village shall pay it's required share for the Ohio Police and Firefighters Pension Fund as set forth in R.C. § 742.01 *et seq.*

**Section 4:** That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of the Village of DeGraff, provide for its continuous uninterrupted services, and to allow for said compensation of employees: and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.
