## ORDINANCE NO. 2023-45

AN ORDINANCE MODIFYING THE COMPENSATION FOR THE VILLAGE OF DEGRAFF VILLAGE ADMINISTRATOR AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO

WHEREAS, the Village of Degraff, through Ordinance No. 2019-27, established that the position of the Village Administrator be a full-time, salaried position; and

WHEREAS, the Village of DeGraff, through Ordinance No. 2019-27, modified the job description of the Village Administrator, including the starting salary and the right to have salary reconsidered within the limits set forth in the Village of DeGraff Pay Scale Ordinance;

WHEREAS, the Village, upon consultation and recommendation of the Mayor based upon performance of the Village Administrator and in accordance with the Village of DeGraff Pay Scale Ordinance, seeks to increase the salary of the Village Administrator by 3% or \$2,434.82 for a total salary of \$83,595.61 per year, effective beginning December 30, 2023; and

**WHEREAS**, the job responsibilities of the Village Administrator as set forth in Exhibit A Ordinance No. 2019-27, shall remain in effect unless specifically modified herein.

NOW, THEREFORE, BE IT ORDANIED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, OHIO:

**SECTION 1:** Salary of the Village Administrator shall increase to \$83,595.61 per year, payable in accordance with the terms of the Village Administrator's contract with the Village.

**SECTION 2:** All other provisions of the Village Administrator's employment contract with the Village of DeGraff, and/or otherwise the Village Administrator's job responsibilities as set forth in "Exhibit A" to Ordinance No. 2019-27, not specifically modified herein, remain in effect.

**SECTION 3:** It is hereby found that all formal actions of this council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4:** This Ordinance is hereby declared to be an emergency measure, in Order to establish revised salary relating to the position of the Village Administrator at the earliest possible time, in light of the fact that a new Village Administrator is being hired, and shall take effect immediately upon the affirmative vote the majority of the members

of the DeGraff Village Council, and to further ensure the health, safety, and morals of the Village of DeGraff.

**SECTION 5:** This Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of said Village of DeGraff and this Ordinance shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.
