

ORDINANCE NO. 2026-14

AN ORDINANCE MODIFYING THE COMPENSATION FOR THE VILLAGE OF DEGRAFF AND VILLAGE OF QUINCY JOINT SEWER PLANT OPERATOR AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO

WHEREAS, the Village of Degraff, through Resolution 2022-30, established that the position of the Joint Sewer Plant Operator be a full-time, hourly position; and

WHEREAS, the Village of DeGraff, through Resolution 2022-30, modified the job description of the Joint Sewer Plant Operator, including the starting salary and the right to have salary reconsidered within the limits set forth in the Village of DeGraff Pay Scale Ordinance;

WHEREAS, the Village, upon consultation and recommendation of the Mayor and the Village of Quincy based upon performance of the Joint Sewer Plant Operator and in accordance with the Village of DeGraff Pay Scale Ordinance, seeks to increase the hourly rate of the Joint Sewer Plant Operator by \$1 per hour, making the new hourly rate \$36.66 per hour, effective beginning August 1st, 2026; and

WHEREAS, the job responsibilities of the Joint Sewer Plant Operator as set forth in Exhibit A Resolution 2022-30, shall remain in effect unless specifically modified herein.

NOW, THEREFORE, BE IT ORDANIED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, OHIO:

SECTION 1: Hourly rate of the Joint Sewer Plant Operator shall increase to \$36.66 per hour, payable in accordance with the terms of the Joint Sewer Plant Operator's contract with the Village.

SECTION 2: All other provisions of the Joint Sewer Plant Operator's employment contract with the Village of DeGraff, and/or otherwise the Joint Sewer Plant operator's job responsibilities as set forth in "Exhibit A" to Resolution 2022-30, not specifically modified herein, remain in effect.

SECTION 3: It is hereby found that all formal actions of this council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and the Village of Quincy Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure, in Order to establish revised salary relating to the position of the Joint Sewer Plant

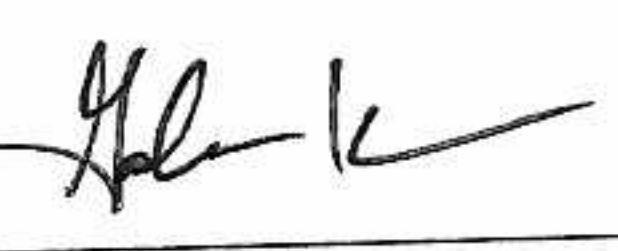
Operator at the earliest possible time, and shall take effect immediately upon the affirmative vote the majority of the member of the DeGraff Village Council, and to further ensure the health, safety, and morals of the Village of DeGraff.

SECTION 5: This Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of said Village of DeGraff and this Ordinance shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.

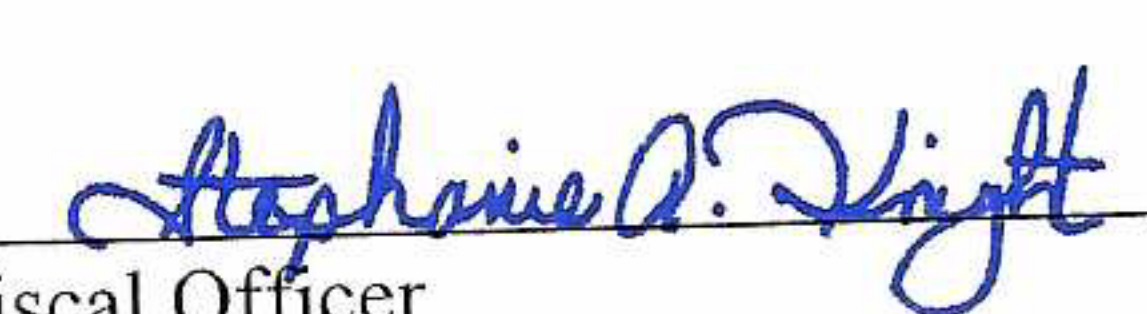
