

# Ordinance No. 2026-01

**AN ORDINANCE MAKING TEMPORARY 2026 APPROPRIATIONS FOR THE CURRENT AND ORDINARY EXPENDITURES OF THE VILLAGE OF DEGRAFF, OHIO, PENDING RECEIPT OF THE AMENDED OFFICIAL CERTIFICATE OF ESTIMATED RESOURCES DURING PART OF THE FISCAL YEAR ENDING DECEMBER 31, 2026, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of De Graff, Ohio, has not received the revised tax budget and the amended official Certificate of Estimated Resources for the fiscal year ending December 31, 2026; and

**WHEREAS**, it is therefore necessary and desirable to postpone the 2026 appropriation ordinance of the Village until the receipt of the Amended Official Certificate of Estimated Resources;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of DeGraff, Ohio:

**SECTION 1.** That to provide for the current and other ordinary expenditures of the Village of DeGraff pending the receipt of the Amended Official Certificate of Estimated Resources based on actual balance on hand, and the enactment of the 2026 appropriation measure, the following appropriations be and they are hereby made, with Exhibit A.

That Ordinance No. 2025-54 passed December 2<sup>nd</sup>, 2025, providing for appropriations for said Village for the year 2026, be and the same hereby is, amended to allow recalculation of funds as set forth as follows, retroactive back to December 2<sup>nd</sup>, 2025, the date Ordinance No. 2025-54 was adopted:



**SECTION 3.** That the Fiscal Officer is hereby directed to file a certified copy of this ordinance with the County Auditor.

**SECTION 4.** That this Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council; and that all deliberations of this Council, and of any committees, that resulted in those formal actions were in meetings open to the public in compliance with law.


