

ORDINANCE 2026-21

AN ORDINANCE REALLOCATING FUNDS FROM PERMANENT APPROPRIATIONS ORDINANCE AND AMENDING THE APPROPRIATIONS ORDINANCE FOR PURPOSES PAYING OPERATING EXPENSES FROM APPROPRIATED FUNDS AND DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO.

WHEREAS, monies within the various funds of the Village of DeGraff may be transferred with the funds according to law; and

WHEREAS, said reallocations are immediately necessary that the clerk be able to pay operating expenses and other expenses of the Village for the preservation of public peace, health, welfare, and safety of the Village of DeGraff;
Pursuant to the Ohio Revised Code, it is necessary to provide for the appropriation of fund for the year 2026.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO:

SECTION 1: That Ordinance No. 2026-06 passed on February 25th, 2026, providing for appropriations for said Village for the year 2026, be and the same hereby is, amended to allow reallocation of funds to/from various fund line items as set forth as follows, retroactive back to January 1st, 2026, the date Appropriations were effective:

General	Contingency	Contingency, Provide and Maintain	1000-930-930	(\$1000)
General	Parks	OPERS	1000-320-213	\$1000

SECTION 2: That it is found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of this council, and that all deliberations of this council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the Village of DeGraff, Ohio, the immediate emergency being to provide for the current expenses and other expenditures (the operating budget) of the Village of DeGraff for the period ending December 31, 2026; therefore, this Ordinance shall be in full force and effect immediately upon its passage and the mayor's signature.
