

**RESOLUTION OF NECESSITY**

RESOLUTION REQUESTING CERTIFICATION FROM COUNTY AUDITOR

PURSUANT TO OHIO REVISED CODE SECTION 5705.03

(Dollar amount of revenue generated by specified number of mills)

WHEREAS, the Council of Village of DeGraff, Logan County, OH,  
Governing body (e.g. board of trustees, etc) Political subdivision  
determines that it is necessary to levy a tax outside the ten-mill limitation, and

WHEREAS, before seeking to have a levy approved by the electors of Village of Degraff,  
Portion of Political Subdivision (authorized to vote on issue)  
the Council must seek the certification of the Logan County Auditor in compliance with  
Governing body  
Section 5705.03 of the Ohio Revised Code, submitted for the General election held  
General, Primary, Special  
on November 5, 2024.

THEREFORE, BE IT RESOLVED, by the Council of Village of DeGraff,  
Governing body Political subdivision  
Logan County, OH, that the Logan County Auditor is hereby requested to certify to the Council:

- 1. The total current tax valuation of Village of DeGraff, and  
Portion of Political Subdivision (authorized to vote on issue)
- 2. The dollar amount of revenue that would be generated by 1.80 mills.  
Millage

BE IT FURTHER RESOLVED that the purpose of the tax is FIRE  
Purpose (use additional lines if necessary)  
supporting FIRE service include operation, improvment for the community benefit.
