

ORDINANCE NO. 2025-44

AN ORDINANCE AUTHORIZING THE MAYOR AND/OR VILLAGE ADMINISTRATOR
TO CONTRACT FOR INTERNET AUCTION SERVICES TO DISPOSE
OF UNNEEDED VILLAGE OWNED PERSONAL PROPERTY AND
DECLARING AN EMERGENCY IN THE VILLAGE OF DEGRAFF, OHIO.

WHEREAS, Section 721.15 of the Ohio Revised Code authorizes the legislative authority of a municipal corporation to authorize the sale of unneeded City owned personal property, regardless of the property's value, by internet auction; and

WHEREAS, the Council of the Village of DeGraff has determined that the Village possesses certain personal property which is not needed for public use or is obsolete and/or unfit for the use for which it was acquired; and

WHEREAS, the Council of the Village of DeGraff, Mayor, and Village Administrator have determined that internet auction is a viable way to dispose of some unneeded Village owned personal property;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF DEGRAFF, OHIO:

SECTION I: That the Council of the Village of DeGraff, Ohio does hereby authorize the sale of unneeded personal property, namely a 2020 Ford Explorer, VIN #1FM5K8AB8LGD19801, for not less than \$ 25 000.00, owned by the Village by internet auction and does hereby authorize the Mayor and/or Village Administrator to enter into contract with GovDeals.com for internet auction services in accordance with the specifications therefore now on file in the Office of the Mayor.

SECTION II: That the terms of the internet auction shall provide that the number of days for bidding on the property shall be not less than ten (10) days and the sales shall be conducted through govdeals.com.

SECTION III: That this Ordinance is hereby declared to be an emergency measure made necessary to protect the health, safety and welfare of said City, provide for its continuous

uninterrupted services, and to allow for the disposition of unneeded personal property at the earliest possible time; and it shall, therefore, be in force and take effect immediately upon its passage and signature by the Mayor.
